2	Core	7KNIA716	The Practice of Mental Health Nursing 2 The aim of this module is to enable you to adapt previous learning to more complex situations and presentations. This will include: vulnerable adults (including their family/carers), patients with comorbid presentations, complex presentations, challenging behaviours, and acute and enduring health conditions. The focus will continue to be on effective assessment and management from a bio-psycho-pharma-social perspective exploring risk assessment and management in greater depth. Management of care will be explored in a range of settings (including locked and restricted environments); sometimes within a family or community context and will include exploration of the wider inter-agency team and multidisciplinary working. Comprising 487.5 practice learning hours: 37.5 hrs - Simulated practice 225 hrs - Placement 1 (6 wks - year 1 term 3) 225 hrs - Placement 2 (6 wks - year 2, term 1)	45	Year 1 - Term 3, & Year 2 - Term 1
