Vice Chancellor Awards

2025 Terms and Conditions

1. INTRODUCTION

1.1 The Vice Chancellor Awards Scheme (the "Award") offers a £10,000 discount from the total tuition fees payable for King's postgraduate taught courses for up to thirty overseas students who satisfy the criteria set out below. For Award recipients, the discount will be automatically applied to their tuition fees.

2. THE AWARD

- 2.1 The Award can only be offered to students meeting the criteria in these Terms and Conditions, particularly those listed in paragraph 3. Eligible students can receive the Award only once.
- 2.2 The Award is available to full-time, on-campus postgraduate taught courses only ("Courses"). It is not available for PGCE courses, research degrees, or for online courses.
- 2.3 The Award can only be applied to Courses starting in the year of application and cannot be applied retrospectively. If an applicant defers their offer of a place on a Course to the following year, a fresh application for the Award will need to be made.
- 2.4 The Award will be applied to a student's tuition fee account in respect of their Course and will not be available in any other form. For example, the Award cannot be used against accommodation fees or other services provided by King's, and no cash alternative will be provided.
- 2.5 The Award is subject to continuing and satisfactory attendance on the student's Course and compliance with King's academic regulations and will be terminated if the student withdraws from their Course, transfers to another institution, fails their Course, or interrupts or suspends their studies.
- 2.6 The Award will be applied to a student's tuition fee account in respect of their Course and the balance shall be invoiced to the student and be payable in accordance with the General Terms and Conditions for Students
- 2.7 In instances where a student withdraws from King's part way through their Course having only paid a portion of their tuition fee, the scholarship will be pro-rated and the student will be required to meet any outstanding tuition fee liability due. (further details of which are set out on the King's website).

3. ELIGIBILITY

3.1 The Award is only available to students who:

are permanently domiciled in India;

hold an offer to study a postgraduate taught degree at King's in the 2025/26 academic year;

have not already received a postgraduate degree from King's or any other institution;

have "overseas" fee status when they enroll on their Course;

have completed an application form.

3.2 The Award is not available to students receiving any other grant, scholarship, sponsorship, or other external funding.

4. APPLICATION AND AVAILABILITY

- 4.1 Every eligible student who applies for the Award by the closing date of 31 May 2025 ("Closing Date") shall be considered for the Award.
- 4.2 Eligible students who apply for the Award after the Closing Date will not be considered for the Award.
- 4.3 Each application will be judged by King's based on its merit. Where two or more applicants are of equal merit, King's may give the Award to applicants who have a protected characteristic that is underrepresented on their Course.
- 4.4 Successful applicants will have the Award automatically applied to their tuition fee account when they enroll on their respective Course. This will be applied as two waivers of £5,000 each, in Oct 2025 and Jan 2026.

5. PUBLICITY

5.1 Whilst studying their Course (and for a period of 3 years after graduating from their Course), recipients of the Award may be asked by King's to become an Alumni Ambassador and complete one or more surveys that evaluate the effect of the Award. They may also be requested to cooperate with publicity activities e.g. appearing in a video or blog / social media content.

6. INTERPRETATION

- 6.1 The awarding of the Award is made entirely at the discretion of King's and the judgement of King's is final.
- 6.2 King's reserves the right to vary or withdraw the Vice Chancellor Awards scheme at its sole discretion, but changes will not be applied retrospectively to any student who is already in receipt of an Award under the scheme unless they withdraw from their Course as set out in paragraph 2.7.
